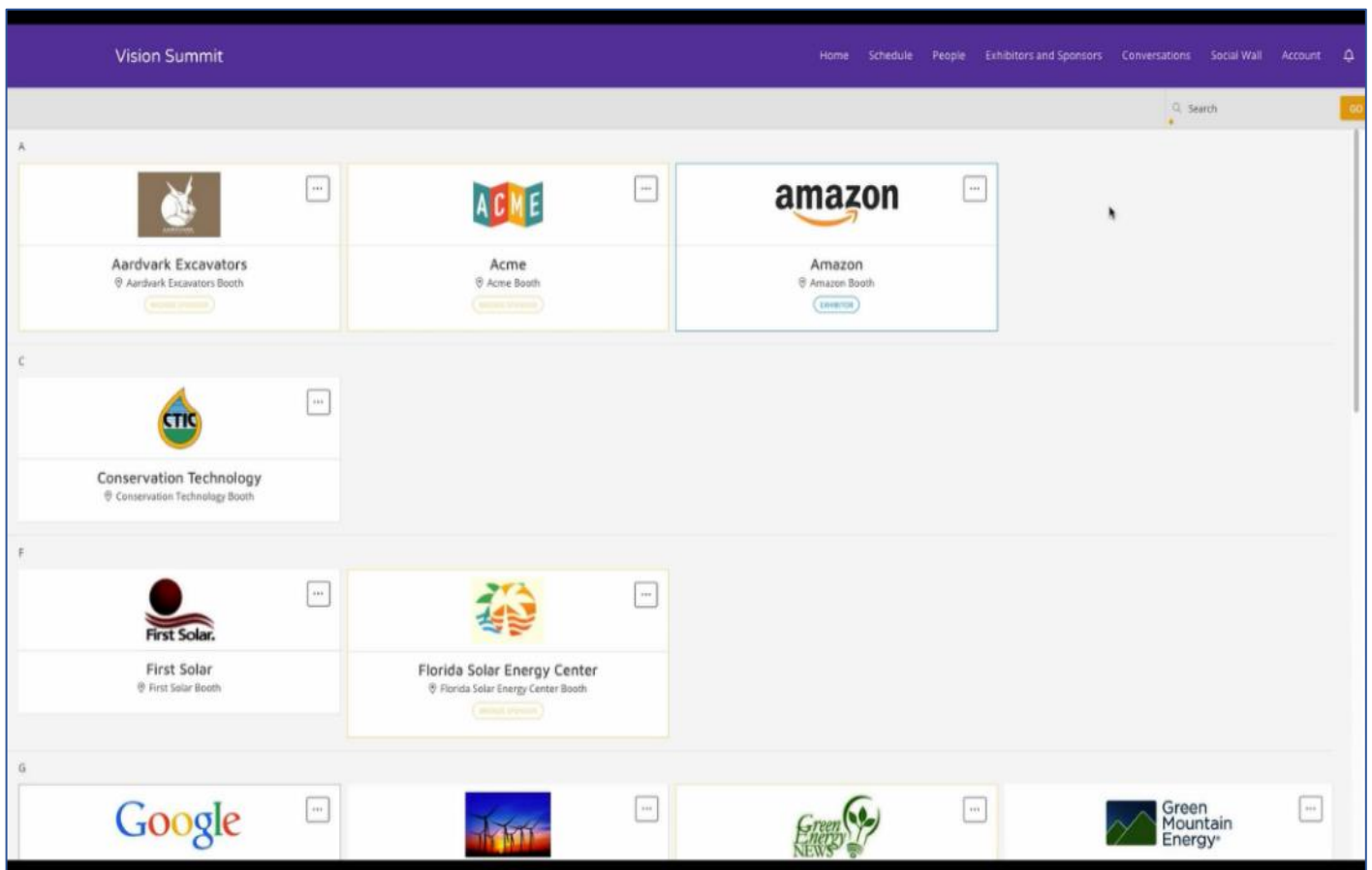
### **Cancellation Policy**
